<p style="text-align: center;"><b>TENTATIVE ABOUT APPLYING</b></p> <ul style="list-style-type: none"> <li>○ Pass-through grant</li> <li>○ No alignment with agency's mission, vision, and values</li> <li>○ No alignment to agency's strategic plan</li> <li>○ Agency is eligible?</li> <li>○ Realistic deadlines - unprepared for grant</li> <li>○ Inappropriate funding amount - limits</li> <li>○ Inappropriate funder - polITICAL, conflict of interest, etc.</li> <li>○ Agency capacity - limited to no staffing resources</li> <li>○ Complex application, requirements, and/or grant terms</li> <li>○ No sustainability beyond the grant period</li> <li>○ Administrative/indirect costs are not allowed</li> <li>○ Match requirement - major agency investment</li> <li>○ New partners are required</li> <li>○ Approved internally (agency policy)</li> </ul>	<p style="text-align: center;"><b>ENCOURAGED TO APPLY</b></p> <ul style="list-style-type: none"> <li>○ Competitive grant</li> <li>○ Odds - &lt;25%, 25-50%, &gt;50%</li> <li>○ Matches elements of agency's mission, vision, and values</li> <li>○ Considering incorporating into strategic plan</li> <li>○ Agency is eligible?</li> <li>○ Realistic deadlines - aware of application and interested</li> <li>○ Appropriate funding amount available</li> <li>○ Appropriate funder</li> <li>○ Is this a speculative proposal by the agency?</li> <li>○ Complex application, requirements, and/or grant terms</li> <li>○ Sustainable - questionable short- and long-term potential</li> <li>○ Administrative/indirect costs allowed</li> <li>○ Match requirement - marginal agency investment</li> <li>○ Partners (collaboration) would make for a stronger application</li> <li>○ Approved internally (agency policy)</li> </ul>
